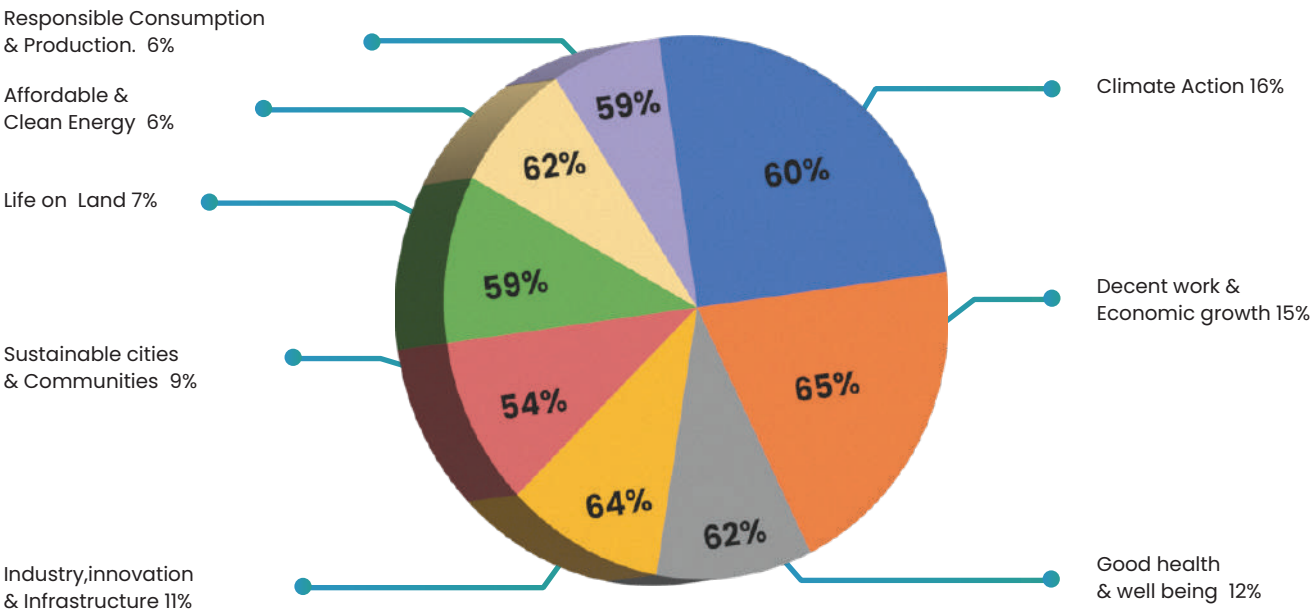

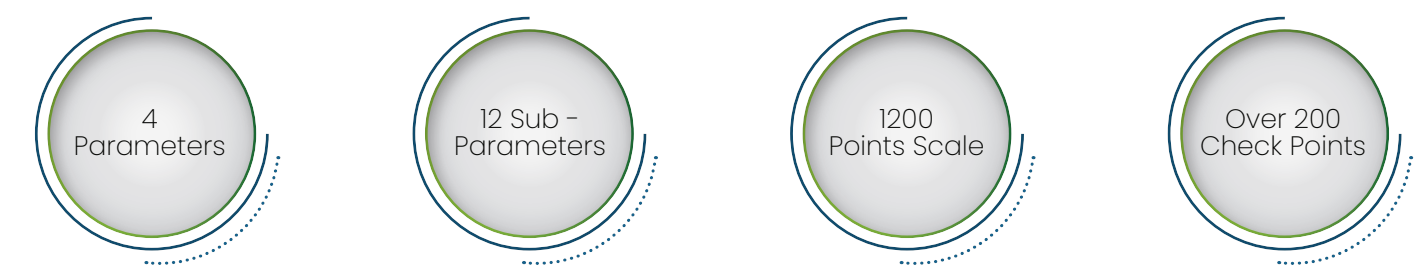
ASSESSMENT SCORECARD

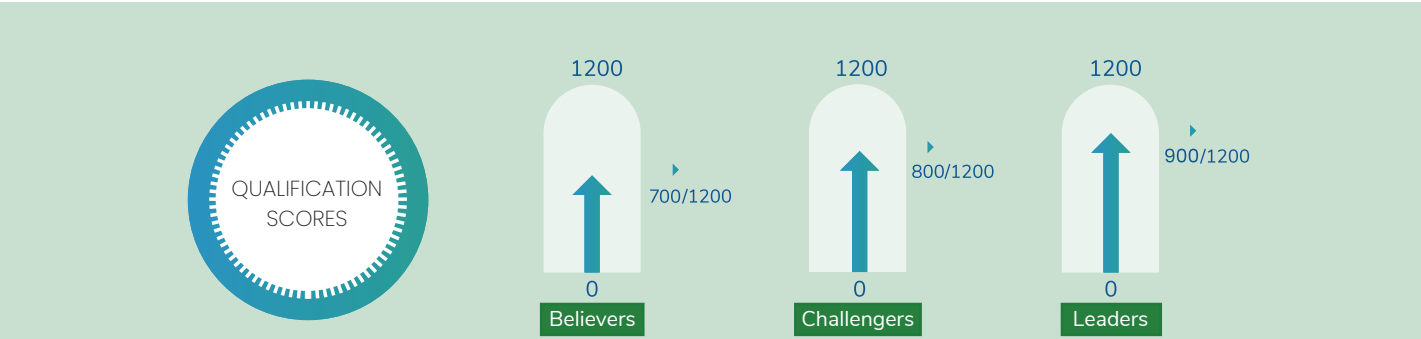


SUSTAINABILITY 2040 – ASSESSMENT FRAMEWORK



QUALIFYING CRITERIA

There are three levels of recognition based on the predefined qualifying scores. These levels of recognition are Believers, Challengers, and Leaders. The qualifying scores are 700, 800, and 900 respectively.



QUALIFICATION BAND



There are three levels of recognition based on the predefined qualifying score foreach of them. These levels of recognition are Silver Award, Gold Award, and Platinum Award and the qualification score, out of 1200, is 700, 800, and 900, respectively. All companies that qualify in any of the three bands will be recognized in their respective band with the "Certificate of Merit. The two highest scoring companies of the year will be recognized with the

"Sustainable Business of the Year" and "Future ready Business /Factory of the Year "

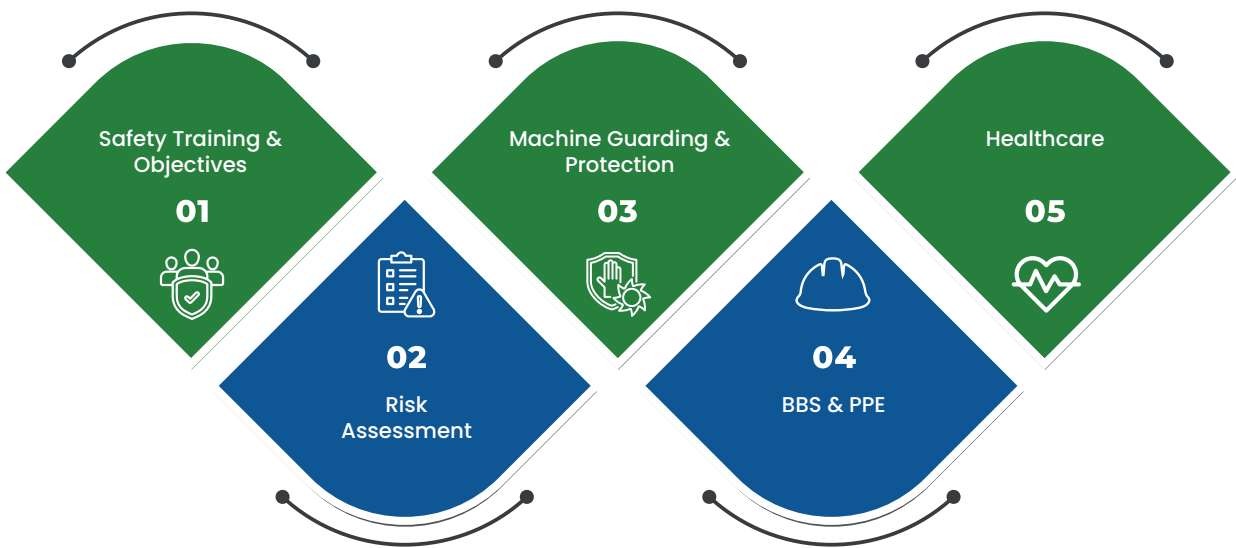
For Sustainability 2040 Awards & PEPA Awards: All companies can apply.
For SMEA & Future Ready Factory 4.0 Awards: Only Manufacturing companies can apply.

SAFE MANUFACTURING EXCELLENCE AWARDS

Assessment will focus on systems and processes that have been deployed to create a safe workplace and policies implemented towards its sustenance and up-gradation. Assessment will begin with reviewing safety management practices and involvement of top management team in these initiatives. Elements of People, Process, and Equipment safety will be evaluated in detail across the supply chain.

Also, initiatives taken towards reducing adverse impacts on employee health will be assessed. Each facility will be evaluated on a maximum of 1000 points. Inputs on strengths and opportunities for improvement will be shared across all five parameters of assessment.

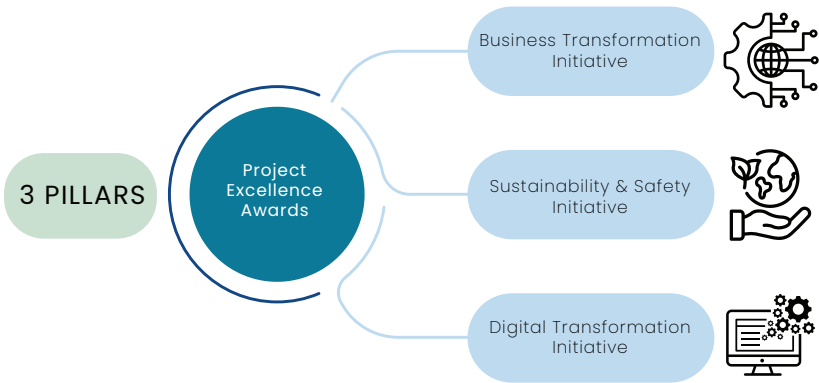

PROJECT ELIGIBILITY & EVALUATION PROCESS

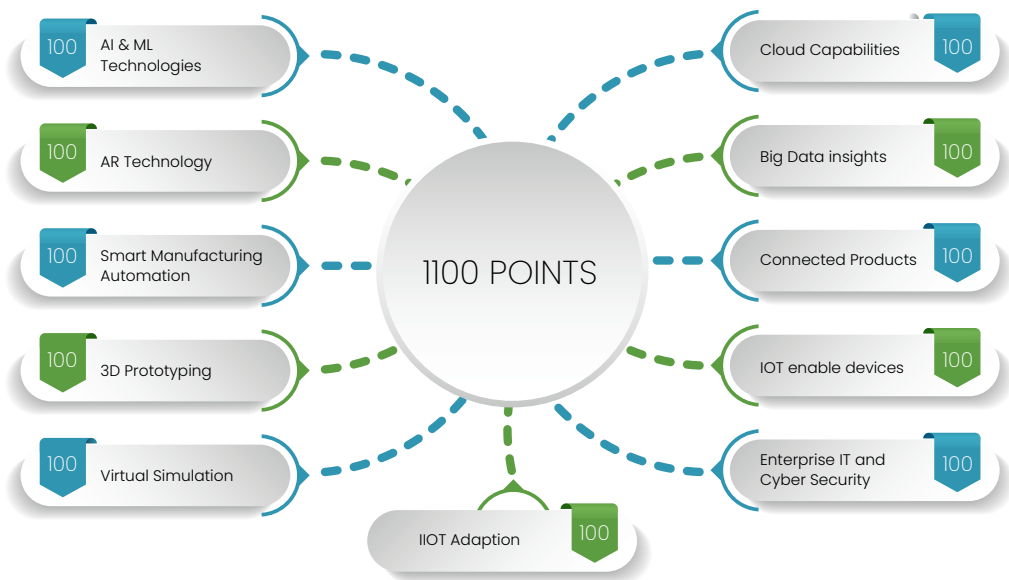

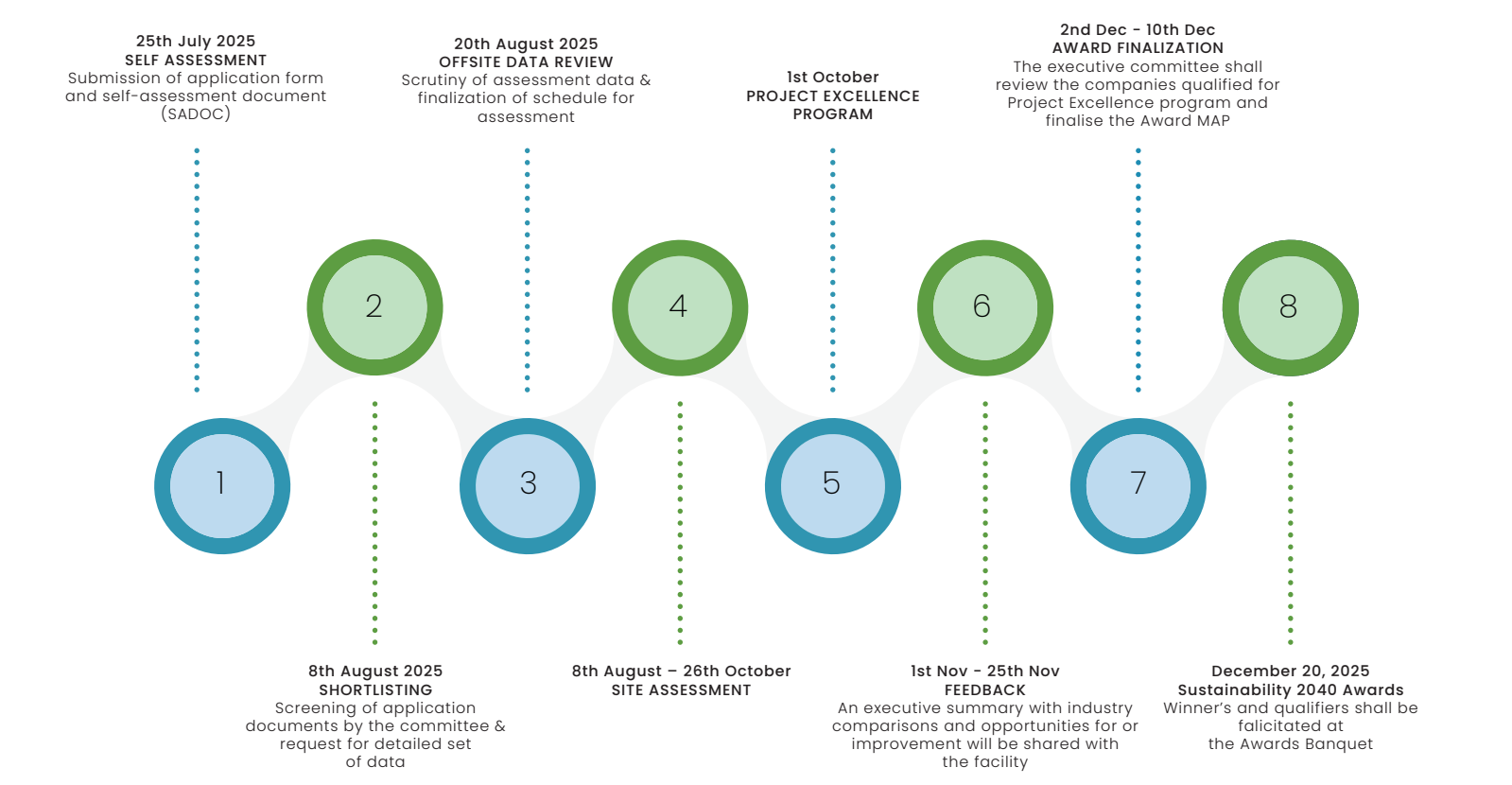
